#### **New Business:**

EMS / Ambulance-

Tony Pantera, City Attorney, is still working with Jolene Maloney, Boise County Attorney, on the Ambulance boundary lines and on fees and rates for covering areas outside of City limits.

#### **EMS Policy-**

Tony did not have a specific part of the EMS policy to address. He will have one at the next meeting.

## Rescue Me Conference-

Clerk Wright explained the Rescue Me Conference and had the conference agenda and information available for everyone. The Conference is an all-day training on Friday, April 15 in Boise and the cost is \$35. Clerk Wright will email the agenda out to everyone.

Councilman Riley **approved** EMS volunteers to attend the Rescue Me Conference on April 15. Councilwoman Cooper **seconded**. All ayes. **Motion carried**.

## ICS Exercise-

John Roberts sent information regarding the ICS exercise to be held Saturday, March 26<sup>th</sup> at the Idaho City High School. The exercise will cover Unified Command and multiple Operations units for all-risk (interagency) incidents. The full scale exercise will be held in May.

## **Public Comment:**

-Martye White-

Martye inquired about the EVOC training. Clerk Wright informed him and Council that the instructor has been in contact with the City and is currently out of town. He is offering to provide class for free and the only cost will be renting the course. Sandy Fenton informs Council that the EMS Department does not need drivers but EMT's instead. Mayor Hanson suggested contacting the Idaho World to do an article on the need for EMS volunteers and drivers.

-Rindy Quijas and Tammy Morganroth gave an update on the Spring Fling Conference held in Grangeville. They reported that the conference was very informative.

# -Tony Pantera, City Attorney-

Tony informed the Council again that he is working on the boundary line issue. Clerk Wright asked if a new map had been provided by John Roberts. A map has not been received at this time.

- -A report was given on the Live Sims Pediatric training that was held on March 9<sup>th</sup>. The EMT's that attended said it was very informative.
- -There were questions on how the EMS Association works. Sandy Fenton informed the Council that the association is comprised of our City EMS Volunteers and that she is the President, Rindy Quijas is the Vice President, Melissa Seibel is the Secretary, and Peggy Goff is the Treasurer.
