606th MEETING OF THE HORSESHOE BEND CITY COUNCIL

Mayor Hanson called the meeting to order with Councilpersons Cooper, Green, and Riley present. Also present, City Clerk Gina Elmer and Attorney Anthony Pantera.

Pledge of Allegiance

Councilman Riley **moved** to amend the agenda to allow for an Executive session under IC 74-2061(B). Councilwoman Green **seconded**. All ayes. **Motion carried**.

New Business:

EMS Director

Mayor Hanson brought to the council's attention that we have only one applicant for EMS Director. She then read William Paine's cover letter. The job opening should be run in the paper another week to see if other applicants will submit their resumes.

EVOC Driver Training

Mayor Hanson said there was EVOC training available. Council would like to make it available to anyone interested in driving the ambulance. We will send a letter to the Fire Department to see if they have anyone who wishes to attend. Tonya Rodgers asked if Council would still follow policy with regards to the training of ambulance drivers. Council absolutely will follow policy regarding this matter. Mayor Hanson will try to set up the training at the earliest date possible.

EMS / Ambulance

The EMTs had nothing to add at this time.

EMS Policy

Tony Pantera distributed a section of the EMS policy that concerns the volunteer Horseshoe Bend EMS personnel. He read each point and the EMTs, Mayor and Council weighed in on each item. Tony Pantera will print a revised copy of this section of the EMS policy to be presented for consideration. Tonya Rodgers brought to the attention that some of the new EMTs are not

signing up for their required 48hrs per month. Mayor Hanson will invite them in individually to talk about this issue.

Public Comment

Tonya Rodgers wanted to let the Council know that it would be beneficial to the EMTs to have a powerlift on the ambulance. The EMTs run into problems lifting on some of their ambulance runs. They are fearful of becoming injured while lifting larger patients. Councilwoman Green knows of a grant that might be available to us to help cover the cost. She will obtain the information for this grant so that the EMTs may apply for it.

Executive Session

Councilwoman Cooper made a motion to go into executive session under IC 74-2061(B) Councilman Riley seconded. Councilman Riley-aye, Councilwoman Cooper-aye, Councilwoman Green-aye. **Motion carried.**
