New Business:

- Fireworks for 4th of July 2023:

- Dale Ortmann: Mr. Ortmann would like to connect his other two properties located at 21 Lucky Ln to city water. He would like to receive an estimate of the cost to hook up. Amy will send the engineering requirements to connect to the system.
- Veterans Memorial Park:

Mayor Goff said that the Chamber of Commerce would like to hold a fundraiser on July 1, 2023. There is an Idaho MMA fighter would like to hold six exhibition fights at the park on July 1, 2023. Kimberly Welsh has already found people willing to by tables for \$2,500.00 to help support a 501C that helps find and prevent abducted children. The fighters would provide the ring and insurance coverage for the event. Mayor Goff will talk to Dennis Chestnut about parking at the school.

Department Updates:

- EMS: Mayor said that Acute is still running but he feels that maybe we should be looking into forming a taxing district to cover EMS.
