**727th MEETING OF THE
HORSESHOE BEND CITY COUNCIL**

Mayor Goff called the meeting to order with Councilpersons Chartier, White, and Burgess present. Also present City Attorney Tony Pantera (by phone) and Clerk Gina Elmer.

Pledge of Allegiance

Councilwoman Chartier made a **motion** to approve the agenda. Councilman White **seconded**. All ayes. **Motion carried**.

New Business:

- **Appoint new Councilmember:** Councilman White would like to see the person appointed be a long time resident. Councilwoman Burgess would like them to each to tell why they would like to be a Councilmember and why they like living in Horseshoe Bend. Cory Robinson says that after being in the military for ten years he decided to live in a van and travel the country for the last few years working construction jobs. He lives in Horseshoe Bend because he prefers small towns and feels that Idaho is the best state by far. Ha has not had much interest in politics but when the Mayor asked him if he wanted the Council position he decided to put in his resume. He works for Boise Fire and teaches classes on Emergency medical and classes on firearms. Jennifer Patterson said it took her a long time to move here from Houston after visiting her parents in Garden Valley during the summers. She moved here in 2015 but always considered Idaho her home. The first three years she lived in her RV and now she lives down Adams Street where they have purchased a home. She has taught high school in Kuna since she moved here but taught in Houston since 2003. She has an engineering degree but prefers to teach high school because it is more personal. She wants to be on City Council because she wants to make the town better but does not want to change the small town feel. Mayor Goff asked Cory to come talk to the Council because of all his volunteer work with the Veterans' Memorial Park. Councilman White states that he would like to see Jennifer appointed. Councilman Chartier would prefer Cory and Councilwoman Burgess said she would pick Jennifer. Mayor Goff appointed Jennifer Patterson as Councilwoman and the City Clerk swore her in.
- **ITD children's crossings and sidewalk safety:**
ITD sent an email containing a draft agreement and resolution for the Council to look over. Councilman Chartier made a **motion** to approve the agreement and resolution. Councilman White **seconded**. All ayes. **Motion carried**.

Old Business:

- **Quest CPA's contract:** The mayor called Tony to see if he had looked over the contract and Tony said it looked good. Councilman Chartier made a **motion** to approve the Quest

CPA's contract and for the Mayor to sign. Councilman White seconded. All ayes. Motion carried.

- **Judicial Conformation:**

Councilwoman Burgess made a **motion** to approve Resolution 2023-01 for Judicial Conformation. Councilman Chartier **seconded. Roll call: Councilman White-aye, Councilwoman Patterson-aye, Councilwoman Burgess-aye, Councilman Chartier-aye. Motion carried.**

Mayor Goff adds that Idaho became a state on July third and there was discussion about the events happening in town.

The city clerk will provide Councilman Patterson with the needed information and paperwork for her new position.
